US Treasury. MCA-Morocco now invites bids from eligible bidders for the acquisition of technical-educational equipment.

Bidding will be conducted through the Shopping procedures as specified in the MCC Program Procurement Guidelines (PPG), and is open to all eligible bidders as defined in the PPG.
