MCA-Morocco now invites bids from eligible bidders for the "Acquisition, Delivery, Installation and Commissioning of technical-educational equipment intended for Vocational Training Institutes benefiting from the financial support of the Charaka Fund".

Bidding will be conducted through the Competitive Selection ("CB") procedures as specified in the MCC Program Procurement Guidelines (PPG) and is open to all eligible bidders as defined in the PPG.
